

PRIVACY POLICY:

This is the web site of **Allen County-Fort Wayne Historical Society (The History Center)**. Our postal address is: 302 East Berry Street, Fort Wayne, IN 46802. We may be reached via e-mail using histsociety@fwhistorycenter.com or you may telephone us at (260) 426-2882.

The only personal data the History Center currently collects through this Web site is the information you voluntarily give us when you use our site. For example, you may use this site to contact the History Center with questions and comments. When you fill out a form on our Web site, you may provide your name and other contact information, including your company's name, your email address, and your mailing address or the mailing address of your company or other personal information.

If you do not want to receive e-mail from us in the future, please let us know by sending us e-mail at the above address. If you supply us with your postal address online you *may* receive periodic mailings from us with information on new products and services or upcoming events. If you do not wish to receive such mailings, please let us know by writing to us at the above address.

With respect to Ad Servers: We do not partner with or have special relationships with any ad server companies.

From time to time, we *may* use customer information for new, unanticipated uses not previously disclosed in our privacy notice. If our information practices change at some time in the future we will post the policy changes to our web site to notify you of these changes and provide you with the ability to opt out of these new uses. If you are concerned about how your information is used, you should check back at our web site periodically. Customers may prevent their information from being used for purposes other than those for which it was originally collected by e-mailing us at the above address or writing to us at the above address. Upon request we provide site visitors with access to transaction information (e.g., dates on which customers made purchases, amounts and types of purchases) that we maintain about them, contact information (e.g., name, address, phone number) that we maintain about them. Consumers may access this information by writing to us at the above address.

Anonymous Data Collected Through www.fwhistorycenter.com.

In addition to the information you provide when you use our Web site, the History Center uses technology to collect anonymous information about the use of our Web site. For example, we use technology to track how many visitors access our Web site, the date and time of their visit, the length of their stay, and which pages they view. We also use technology to determine which web browsers our visitors use and the address from which they accessed our site.

This technology does not identify you personally. It simply enables us to compile statistics about our visitors and their use of our site. The History Center uses this anonymous data to improve the content and functionality of our Web site, to better understand our customers and their needs, and to improve our services.

Cookies.

A cookie is a small piece of information that is sent to your browser and stored on your computer's hard drive. Cookies do not damage your computer and they cannot be used to discover the identity of a user. You can set your browser to notify you when you receive a

cookie. This enables you to decide if you want to accept it or not and whether you are required to accept the cookie to view certain content. FWWB may use cookies to "persist" a user session — that is, to maintain connection with a user as he or she moves through an application or series of web pages. The purpose of cookies in this context is to remember user inputs. For example, a "shopping cart" application records purchases up through the time a user reaches checkout.
